Keeping Furniture Alive Through "New2U Program"

This year MedStar Union Memorial Hospital enhanced its recycling program and focused on bulk waste, specifically office and waiting room furniture. The hospital evaluated its furniture purchasing and discarding processes and established a new process with the facilities department to "ask" before trashing. The program was branded 'NEW2U'.

Unused and/or discarded furniture is identified and collected in a common location. Each item is photographed and tagged with an ID#, brief description, and date. The hospital's inventory of items is posted via a 'NEW2U' link on the hospital's green team website. Department decision makers are educated and reminded to check the NEW2U collection before ordering new furniture. Senior Management is also held responsible for ensuring that departments check the inventory before approving new purchases.

Associates are able to browse and select items when the store is open. MedStar Union Memorial's goal is to re-purpose items within the facility and to encourage repairs or reupholstering. If there is no need in-house, associates are given the opportunity to purchase items for a nominal fee. Some items are donated to non-profit groups while other, more damaged items are picked up by a recycling vendor.

MedStar Union Memorial's 'NEW2U' program is saving money, diverting waste from the landfill,

and encouraging employees to re-use before purchasing. In the first year, 332 items were adopted internally, 52 were purchased, and 78 were donated to non-profit groups.

Trash Cans That Fit Your Needs: Utilizing Red Bag Roll Dispensers

When MedStar Harbor Hospital signed a new waste contract with its vendors, very ambitious objectives were set, including a goal of 12% regulated medical waste (RMW). The only way to achieve this goal was to restructure the way in which the hospital handled waste throughout the facility. MedStar Harbor Hospital worked with its vendors to create custom waste flows based on RMW generated by each department. One such strategy was the use of red bag roll dispensers.

A dispenser was installed in each patient room to replace a standard step-on container. Clinicians pull a bag when needed for regulated medical waste. This bag is tied and taken to a communal container conveniently located on the unit. The hospital first deployed this waste flow in areas that produce very minimal amounts of regulated medical waste, but as the program went along, more and more departmental managers wanted them in their areas. MedStar Harbor Hospital now has dispensers in its medical/surgical units, specialty practice offices, and emergency department.

The program is clearly working. RMW accounted for 26% of the waste stream in June 2012—down from 79% in December 2011. That means the hospital removed about 150,000 pounds of RMW per month from the waste stream. MedStar Harbor Hospital believes that this strategy makes its employees better aware of what they are throwing away and subsequently more aware of their and the hospital's environmental impact.



Johns Hopkins Hospital's New Buildings Promote Wellness



Greenhealth Magazine, the official membership magazine of Practice Greenhealth, published an interview with architect Carolyn BaRoss, of Perkins + Will, who worked on Johns Hopkins Hospital's new Charlotte R. Bloomberg Children's Center and Sheik Zayed Tower, two buildings both designed with patient and staff wellness in mind. BaRoss believes that when it comes to design, function doesn't have to come at the expense of aesthetics. Art, natural lighting, and beautiful views can all have a positive impact on patients and staff. Perkins + Will made sure to engage nature wherever possible in the new buildings, with gardens visible indoors and out, daylight-filled spaces, and the use of light-reflective neutral colors.

The design team also used furnishings made without vinyl and used rubber flooring where possible. Low VOC paint was used for the walls.

Top 5 Things That Save Energy in Hospitals

Lighting: Retrofits with newer lamps and remove unnecessary lighting

Ventilation: Re-commission the economizer control on air handling units

Water Heating: Preheat domestic hot water with condenser heat and switch to low-flow plumbing fixtures

Space Heating: Plan a steam trap maintenance program to prevent leaking

Space Cooling: Invest in technology to optimize the control of central cooling systems.

How to Overcome Sustainability Challenges

An article in Environmental Leader examines the challenges of incorporating sustainability practices into an existing business, and some possible solutions. Author Jeffrey Puritt, President of TELUS International, focuses on the following areas:

- **Senior Support:** Becoming a sustainable business requires senior-level buy in – and some of your senior team may be more supportive than others.
- **Employee Engagement:** Initiating positive change will have a much greater chance of success if employees feel proud and engaged.
- **Cost:** Fundamentally, businesses are designed to make money – and introducing sustainability initiatives usually comes at a cost.
- **Metrics:** Without a regulatory body, it's difficult to determine what to measure. Sustainability initiatives are particularly challenging as they often affect society at a macro-level, which cannot always be quantified.
- **Suppliers:** Identifying suppliers that match your business needs as well as your sustainable values is time consuming and difficult.
- **Consumers Don't Care:** Consumers do not consistently communicate their desire for sustainable products when exercising their purchasing power.

Updated Hazardous Waste Pharmaceuticals Web Page



The EPA is in the process of developing a new proposal to establish appropriate standards for the management and disposal of hazardous waste pharmaceuticals generated by healthcare facilities.

This most recent effort is a continuation of the December 2, 2008 proposal to add hazardous waste pharmaceuticals to the Universal Waste Program. Public comment on the December 2008 proposal revealed numerous concerns over the lack of notification requirements for those facilities that generate, handle or transport "universal waste" pharmaceuticals as well as for the lack of tracking requirements for the shipment of these wastes. Therefore, the Agency decided to not finalize the 2008 proposed rule, but rather develop another proposal for new standards for the management and disposal of hazardous waste pharmaceuticals that are generated by healthcare-related facilities. Johnson & Johnson removing harsh chemicals from adult toiletries and cosmetic products by 2015



TRENTON, N.J. — Johnson & Johnson plans to remove trace amounts of potentially cancer-causing and other dangerous chemicals from nearly all its adult toiletries and cosmetic products worldwide within 3 1/2 years.

The health care giant late last year pledged to remove "chemicals of concern" from its baby products sold around the world. That change came after a large coalition of health and environmental groups began pressing J&J more than three years ago to make its personal care products safer.

The company told The Associated Press in an exclusive interview Tuesday that it remains on track to have baby products, including its Johnson's No More Tears baby shampoo, reformulated with safer ingredients by the end of 2013. Adult products will be reformulated by the end of 2015.

Inside the effort to strip toxics from U.S. hospitals

It's not easy to wrangle the largest players in any industry to give up competitive advantages.

But that's what the five largest health care group purchasing organizations (GPOs) in the U.S. (Amerinet, HealthTrust, MedAssets, Novation and Premier) did when they agreed to work together on a standardized list of questions for suppliers about their products' impact on humans and the environment.

It's a move that can have a big impact on greening the industry's supply chain: Purchases of the five GPOs represent 90 percent of all GPO purchases and total \$135 billion a year, according to Curtis Rooney, president of the Health Care Supply Chain Association.

"These GPOs put competition aside to show that they are committed to sustainability," said Beth Eckl of Practice Greenhealth, a nonprofit organization of more than 1,200 health care organizations (including hospitals and GPSs) aimed at embedding sustainable practices in the health care industry.

While [Kaiser Permanente had developed its sustainability scorecard in 2010](#), there was still a need for standardized questions in order to compare each product using the same measures, according to Eckl, the director of the organization's environmental purchasing program.

"Purchasers in general are in a key position to affect sustainability," Eckl said. "What comes in the front door has an impact out the back."

Buy Local Challenge: Overwhelming Success

This year for the first time, Health Care Without Harm adopted the Buy Local Challenge resulting in 82 health care facilities participating in 15 states across the U.S. and the District of Columbia by serving at least one local food each day from July 21-29. More than 50 of these facilities are in MD, DC and N. VA, spending over \$50,000 on local foods during the week and engaging over 1000 employees, patients and community members in taking the pledge to eat local foods. Hospital executives from at least 6 hospitals also took the pledge to eat local foods for the first time this year. At least 11 health care facilities, primarily in Maryland, purchased local beef and/or poultry during the week. Long-Term Outcomes after Phthalate Exposure: Food Intake, Weight Gain, Fat Storage, and Fertility in Mice

[Research with mice reports](#)

that exposure to the phthalate DEHP causes adverse effects both to the pregnant mother and offspring exposed in the womb. Impacts include significant weight gain, changes in hormone levels and at the highest exposure level, 100% spontaneous abortion.



DEHP is commonly found in hospital medical supplies like IV tubing and bags. However, alternatives have become more commonplace as the health effects of DEHP become more documented. Talk to your supplier about DEHP-free products.

Plastics Chemicals Linked to Diabetes in Women; Blacks and Hispanics Most Exposed

A group of chemicals found in household plastics and medical supplies is linked to higher rates of diabetes in women – up to double the rate for women with the highest levels, according to new research led by Harvard scientists. Blacks and Mexican Americans and women living in poverty are exposed to the highest levels of some of these compounds, called phthalates. “It’s extremely likely that phthalates and other chemical contaminants will turn out to be a big part of the obesity and diabetes epidemic, but at this point we really don’t know how these chemicals are interacting with each other, or with the human body,” said Richard Stahlhut, a University of Rochester scientist who co-authored the study.
